REGARDING CONDITIONS FOR THE USE OF AERODROMES BY PRIVATE FLIGHTS

Airport administrators confirm aircraft operators items as follows

1. Measures to Prevent Objects Falling off Airplane

At applied aerodromes¹, airport administrators shall confirm the following from 30 MAR 2019.

Operators of airplanes (airplanes with a maximum takeoff weight of more than 5,700 kg; hereinafter the same) shall sign the Statement to take the measures to prevent objects falling off airplanes.

Airport administrators shall confirm that airplanes operators sign and submit the “Statement to Prevent Objects Falling off Airplanes” (See ATTACHMENT 1) at the time of the submission of a notification of the use of the aerodrome.

2. Relief system for damaged party by falling objects from aircraft

At applied aerodromes¹ airport administrators shall confirm the following from 30 MAR 2019.

On the assumption of the damage to human life and body or property to be caused by falling objects from aircraft in operation, operators of aircraft applied for the use shall agree to the arrangements of the Memorandum of Agreement which undertakes the compensation in proportion to the number of aircraft, when the aircraft of its own use is included in the aircraft identified as highly probable aircraft used for the operation with falling objects by the Falling Object Confirmation Committee established in Regional Civil Aviation Bureaus of MLIT.

Airport administrators shall confirm that aircraft operators agree to the arrangements of the “Memorandum of Agreement on Relief for Damage caused by Falling Objects from Aircraft” (See ATTACHMENT 2) by the signature of the notification of the use at the time of its submission.

3. Insurance and other conditions.

At applied aerodromes2 Airport administrators shall confirm the following:

- i) Aircraft shall be insured by the aviation insurance (the third party liability insurance) except flights by the government or for emergency purpose.
- ii) Avoid law violation and interference on airport administration when in use.
- iii) No person who has been sentenced to a penalty of imprisonment or more severe punishment for violation of any relative laws of using airport, and less than two years have passed since completion of the sentence or since it was suspended.
