### Hours of Service for Entrance and Clearance

Inspection services for the entrance/arrival of aircraft at Laredo International Airport are generally available seven days per week, 24 hours per day in accordance with the port's permission to land procedures.

Commercial aircraft operators departing the U.S. must obtain an outbound clearance by contacting CBP directly.

### Permission to Land Procedures

Laredo International Airport (KLRD) is designated as an "international airport" or "airport of entry" [19 CFR 122.1(e);19 CFR 122.12].



Pilots must secure permission to land by contacting CBP no later than one hour prior to departure from foreign. Permission to land is granted with a tolerance of (+/-) 30 minutes. If your ETA deviates outside those parameters, you must contact CBP to resecure permission to land. If the flight is canceled or diverted to another airport, please contact CBP at KLRD to notify of the change.

### Inspection Process

- Aircraft should taxi directly to the FIS upon arrival.
- Be prepared to present passports, visas, pilot's license, medical certificate, aircraft registration, and user fee decal (if appropriate).
- Please adhere to guidance and requirements for international travel from other United States government agencies.
- Please follow any additional instructions provided by a CBP Officer whether by phone, email, or in person.
- Passengers can depart directly from FIS at the conclusion of their inspection.



### Special Procedures/Miscellaneous

- Pilots must secure permission to land by contacting CBP during regular office hours.
- Any aircraft granted outbound clearance must notify CBP directly, at the phone numbers listed above, if the approved date/time of departure changes.
- Laredo Command Center - For use only if communications are down at the Laredo International Airport.
- The maximum number of passengers KLRD can accommodate at the FIS is 30 passengers. If there are more than 30 passengers, the passengers will be cleared at the main terminal. For flights with more than 30 passengers please request guidance from the control tower and the City of Laredo. Contact CBP in advance of arrival for further guidance.
